Announcement of the first private insurance for fitness training program using HAL ~AIG General Insurance Company will coordinate with CYBERDYNE's Robocare Centers to support its insured persons with severe disability~

CYBERDYNE, INC. [President and CEO: Yoshiyuki Sankai (the "Company")] announced that AIG General Insurance Company, Ltd. ("AIG General Insurance") is starting a service to cover the cost of the Company's training program with HAL for insured persons by AIG General Insurance automobile insurance and accident insurance starting from January, 2019.

In this service, AIG General Insurance will cover up to 10 training sessions with HAL (excluding related fees such as travel expenses) in order to support the recovery of insured persons by its insurance, who suffered from diseases such as spinal cord injury. For further information on eligibility of utilizing this service, please refer to the documents published by AIG General Insurance. The service could be used in the five facilities listed below starting from January 2019 and the Company plans to expand the facilities where this service can be used.

- CYBERDYNE STUDIO (Tsukuba City, Ibaraki Prefecture)
- Shonan RoboCare Center (Fujisawa City, Kanagawa Prefecture)
- Oita RoboCare Center (Beppu City, Oita Prefecture)
- Suzuka RoboCare Center (Suzuka City, Mie Prefecture)
- Osaka RoboCare Center (Sakai City, Osaka Prefecture)

The Company and AIG Japan Holdings Kabushiki Kaisha ("AIG Japan") signed a business collaboration agreement on November 2016. Since the signing, the two companies worked together to combine innovative Cybernic Technology of CYBERDYNE and AIG Japan's globally accumulated knowledge in the development of its products and services in order to develop and create businesses that seek to maintain, improve and promote the health of all people and accelerate the "Cybernic Revolution" in the insurance industry. In accordance with the business collaboration agreement, the two companies conducted a campaign to provide training with HAL to school students



under 18 with functional disability in the lower limb from October 2017 to September 2018. The service that is explained in this announcement is designed for wider target and it does not have a period where the service is scheduled to end.

The Company will continue to coordinate with AIG Japan to realize the Cybernic Revolution in the insurance industry, which will contribute to maintaining, improving and promoting health of all people.
