Sapporo Robocare Center opens ~First Robocare Center in Hokkaido~

CYBERDYNE, INC. 【Tsukuba, Ibaraki, CEO: Yoshiyuki Sankai (the “Company”)】 in coordination with Reha Innovation Co., Ltd. 【Sapporo, Hokkaido, President: Nozaki Madoka】 and the Company’s wholly owned subsidiary Shonan Robocare Center, announced to open Sapporo Robocare Center in Sapporo City, Hokkaido Government.

Prior to opening of Sapporo Robocare Center, the Robocare users in Hokkaido was forced to travel outside of Hokkaido. To overcome that difficulty, the Company received number of request to establish a Robocare Center in Hokkaido. The Company succeeded to coordinate with Reha Innovation Co., Ltd., which offers both facility based and visiting training service in Hokkaido. As Reha Innovation were also an experienced user of HAL System the coordination led to the establishment of Sapporo Robocare Center.

Similar to other Robocare Centers, Sapporo Robocare Center will utilize CYBERDYNE’s Wearable Cyborg HAL, a device that is activated by the intended motion of its wearer, to offer the state-of-the-art HAL FIT training program. The HAL FIT program is an advanced training program for visitors with disabilities or physical weaknesses. Additionally Sapporo Robocare Center will utilize the expertise of Reha Innovation Co., Ltd. On home visiting training service using HAL for Well-being Single Joint Type and HAL Lumbar Type for Living Support for Well-being. Furthermore, the visiting training service with HAL offered by Sapporo Robocare Center will be covered by public insurance system^{*2} allowing the user to take part in HAL FIT program with less financial cost.

Sapporo Robocare Center will become the 12th Robocare Center to offer this advanced training program, following facilities like Okayama Robocare Center (opened May 23), Sendai Robocare Center (opened May 24), Hiroshima Robocare Center (opened May 23), Sendai Robocare Center, Hiroshima Robocare Center (opened July 1), Kitakyushu Robocare Center (opened July 1) and Nagoya Robocare Center (opened August 1). Additionally the Company schedules to open new Robocare Centers such as Tokyo Robocare Center (scheduled for opening on September) and Kobe Robocare Center (scheduled for opening on October). For the HAL FIT program offered in the related Robocare Centers, some private insurance contracts^{*3} and shareholder benefits^{*4} can be used. Upon using the aforementioned scheme, there are certain conditions, which would be applied, so

please check the appendix for the details.

The Company will continue to expand its business in order to improve access by the potential visitors. Through this endeavor the Company hopes to make contribution in the formation of a society where people with disability and elderly could continue to have initiative in their action.
